Report From the Director

This School Year we saw the beginning of a newly remodeled Newport site and the inauguration of three full day classes, one at each of our three locations. Our Newport site expansion has given us more room and the new paint on the outside and expanded parking makes it look brand new. We are very pleased with the outcome.

Full day classes were very successful. Although we have not been given funds for further expansion into full day, we hope that in the future funds will become available.

We have 100% eligible children served this year.

With the assistance of our innovative "Skill Builders" in the classrooms to assist with children needing extra support, many children adapted more easily to the challenges of the new experience of pre-school.

Once again we have received support from our friends at The Spirit Mountain Community Fund, Lincoln County Social Service Agency grant and the, Samaritan Social Accountability Grant. These funds assisted in our in classroom support of high needs children as well as educational materials and therapeutic supports. We are fortunate to have our services to children and families valued highly.

Moving out of poverty, especially when it is generational, presents many challenges. We work in partnership with our families to support, encourage and assist in this exciting and life changing process. With our excellent staff, community partnerships, CSC programs that offer assistance and the continual quality improvement work, Our children will remember us into their future as successful students and citizens. As one child who moved on into elementary school once said when passing my office while showing his little sister the school, "You are going to like it here, you'll see! I still miss it." That is the sound of making a difference in a child's

Mental Health and Disability Services

The 2017-18 school year shows another year with increased services and referrals offered to families in the area of Mental Health at CSC Head Start.

As we continue to build relationships with mental health professionals in our community, we are able to share these resources with our Head Start families when needs are expressed. Children's Advocacy Center, Olalla Center for Children, and Coastal Center for Collaborative Health are all valued partners with Head Start. They have followed the same model to bring services to children directly in our

classrooms through the support of trained Skills Builders. Their professional services reach beyond the classroom and are also available to families. These partnerships have led to easier access to programs and services for our families, greater emotional wellness within families, and resulted in fewer disturbances and increased positive behaviors in the classroom.

Working together with teachers and families, the Mental Health and Disabilities Content Specialist helps to identify students who may be at risk. 34 families have received services in the area

of mental health this school year.

22 referrals were made this year to Linn Benton Lincoln Education Services District, which provides Early Childhood Special Education services to children in our area. Head Start has maintained over 10% enrollment of children with diagnosed disabilities. Program wide, 21% have Individualized Family Service Plans and have received services.

As this year comes to an end, we look forward to continuing these services with families and children next year.

Health



e have successfully supported our children's health this year, as the following health statistics chart demonstrates. There are increases in physical and dental exams resulting from Teacher/Advocates working with parents on a monthly basis.

Health and Nutrition Supervisor attends the Lincoln County Public Health Committee, meetings, where she shares pertinent information and the group makes recommendations related to any health matters that came up throughout the school year. We partnered with Capitol Dental in Salem to have a dental hygienist provide three dental screenings and fluoride varnishes for children at each of our sites. We also continue to partner with Elks Children's Eye Clinic/OHSU Casey Eye Institute Vision Screening program to have all our children's vision tested. OSU Extension Nutrition Program provided

nutrition education lessons in each classroom and presented to parents at a Family Meeting. OSU Extension Nutrition Program focuses on healthy eating and active living. As a part of this mission, they offer CSC Head Start classes supplemental health and nutrition instruction. We are pleased to have a great network of vital community partners.

ealth and Nutrition Supervisor (HNS) developed and maintains many community partnerships, effectively using resources such as Oregon Health Plan (OHP) portal, Women, Infants and Children (WIC), Health Services Advisory Committee (HSAC) and dental provider relationships. OHP portal gives the HNS access to look up children's insurance information which includes last dental visits. WIC's collaboration with Head Start allows us to better assist families served by both programs. HNS ensures services are not duplicated, receives accurate information about child's height, weight and hemoglobin count for iron anemia. Our HSAC includes a broad range of professionals such as a registered dietician, physician assistant, public health staff, mental health consultant and Head Start parents. We all work together to find the best way to meet the needs of children and families in our community. The great dental provider relationships allow HNS to call dental offices to determine when children were seen, if they need dental treatment and whether or not treatment was completed.

School Readiness & Transitioning to Kindergarten

he Head Start approach to school readiness: children are ready for school, families are ready to support their children's learning, and schools are ready for children. CSC Head Start (CSCHS) faithfully applies this approach in its work with children, families, and local schools to promote school readiness for each child.

Children are prepared for school by dedicated teachers, developmentally appropriate teaching strategies, research based curricula and an assessment tool aligned to Head Start Early Leaning Outcomes Framework. We partner with families to prepare them for their child's entry into kindergarten. School readiness goals are reviewed with parents, activities for home learning are shared, and their child's progress is discussed throughout the year. Local schools are ready for incoming kindergarten children as kindergarten teachers

attend Head Start Family Nights, meet with CSCHS teachers, and welcome CSCHS children and families to their new school for our annual fieldtrip.

Kindergarten transition activities sponsored by CSCHS and Lincoln County School District (LCSD) connect children and families with their future school, begin positive relationships with future teachers, and promote a successful, happy start of school.

In addition to monitoring children's progress in meeting school readiness goals as described below, we receive Oregon Kindergarten Assessment scores for former CSCHS children who have entered kindergarten in LCSD. We are proud to report former CSCHS children entering kindergarten in 2017 met or exceeded LCSD averages in each assessment area.

our assessment tool's learning objectives in alignment with Lincoln County school readiness skills and the Head Start Early Learning Outcomes Framework. 22 learning objectives with specific levels of development were adopted as our school readiness goals. The majority of levels of development selected for school readiness goals are on the high end of preschool learning expectations.

Chart below shows the percentage of school readiness goals learned by CSC Head Start children entering kindergarten this fall in five essential domains of school readiness identified in the Head Start Early Learning Outcomes Framework. Three times a year we review school readiness outcomes data in order to implement instructional strategies in the classroom and family engagement strategies in the home to increase children's learning.

Aggregated program-wide data for the 2017-2018 school year:

The developmental progress of all children is monitored and aggregated for 60 learning objectives, in addition to tracking school readiness goals development for children transitioning to kindergarten. Our assessment tool provides widely held expectations for each age-group, three year olds and pre-kindergarteners, in six areas of learning. If a child's knowledge, skills, and behaviors are assessed at a level within the range for the child's age, the child demonstrates widely held expectations for the area of learning. Widely held expectations are not shown for the areas of science and technology, social studies, the arts, and English language acquisition as research does not currently support definitions of expectations. CSC Head Start children demonstrated considerable progress over the course of the year as indicated in table below. By spring reporting period, over 90% of children met or exceeded widely held expectations for each area of learning.

SC Head Start provides instruction in 10 areas of development and learning aligned with the Head Start Early Learning Outcomes Framework.

<u>Cognitive</u> pertains to child initiative, curiosity, engagement, persistence, problem solving, and symbolic representation.

The Arts includes early music concepts, visual arts, dramatic play, creative movement and dance.

<u>Mathematics</u> includes skills in numbers and operations, geometry, patterns and beginning measurement concepts.

English Language Acquisition includes receptive and expressive English language skills.

<u>Literacy</u> includes book appreciation and knowledge, phonological awareness, alphabet knowledge, early writing and print concepts.

<u>Language</u> includes receptive and expressive language abilities



<u>Science & Technology includes</u> observation, description, prediction, explanation classification and questioning skills.

Physical includes physical health status, health knowledge and practices, gross motor skills and fine motor skills.

<u>Social—Emotional</u> includes the areas of social relationships, self concept, self regulation, emotional and behavioral health.

Classrooms were brimming with proud families and children as a year of learning and friendship was celebrated. Executive Summary of Community Assessment Update 2018 (excerpts)

Introduction

Community Services Consortium (CSC) Head Start provides Head Start services to families with preschool age children in Lincoln County, Oregon through its three preschool centers in Lincoln City, Newport and Toledo, Oregon. Head Start is a federally funded early childhood education program that provides preschool services, health services, mental health services, and other social services to low income 3 and 4 year old children and families. Head Start programs are required to conduct a Community Assessment every 5 years which identifies the number of eligible children in the program's service area, demographic information about those children and the health, mental health and other social service needs of families.

Economic Issues

A variety of indicators show that Lincoln County has a high level of need for Head Start services when compared to the rest of the state of Oregon and the country as a whole. In 2016 the poverty rate for young families in Lincoln County was 36.3%, up from a 7 year low of 22.2% in 2010. This is significantly higher than that of the rest of the state, which was 18.7% in 2016. Median family income in Lincoln County is on average 18.2% lower than that of the state of Oregon. The distribution of income by households in Lincoln County show that poverty is more acute in CSC Head Start's service area, with nearly 1 in 5 (19.6%) households making less than \$25,000 a year, compared to 14.7% of households in the state of Oregon and 15% in the United States as a whole.

Capacity

According to American Community Survey data there are an estimated 290 income eligible Head Start children in the service area with about 2,287 children under age 5 in total. Combined Head Start funded enrollment for Lincoln County is about 224, with CSC Head Start's 160 funded slots and Confederated Tribes of Siletz Indians Head Start's 64 funded slots. On average CSC Head Start serves about 160 eligible children each year while the Siletz Head Start program currently serves about 40 eligible children as of February 2018. Combined these two Head Start programs serve about 200 eligible children. (130% & over income slots are available throughout the year)

Health and other issues are being identified and addressed

Health issues among children in the program are being identified and addressed. Of those children newly diagnosed with medical conditions all received services for those conditions in the 2016-2017 school year. A steadily increasing percentage of children diagnosed as needing dental care have been connected to dental services, going from 67.7% in the 2011-2012 school year to 86% in the 2016-2017 school year. All children with disabilities have received services for their disability over at least the 6 years worth of data that was analyzed, though the program has always focused on serving children with disabilities. Staff in the program credit this to strong family advocacy work.

Conclusion

Families in Lincoln County, Oregon exhibit higher levels of poverty than the rest of the state. This is a trend that has remained consistent over the past 10 years at least. However, Head Start is well positioned in the county to meet the needs of low income families with preschool age children. Families enrolled in CSC Head Start are effectively connected with health and disabilities services. The current program option continues to serve the needs of the community with the addition of the full day classes (3) at each location as there have been no significant changes in the community/county/demographics.
